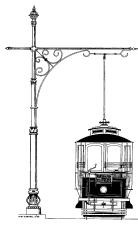

The minimum age for membership is 16 years. Applicants are required to subscribe for a minimum of one (1) \$2.00 share in the capital of the Co-operative Society. Maximum permitted shareholding is not to exceed 20% of shares on issue, or 1000 shares, whichever is the lesser.

Membership fees for the CALENDAR YEAR are \$90.00, or \$75.00 for Australian pensioners, Seniors Card holders or full-time students under 21 years of age and includes the magazine *Trolley Wire*, published quarterly, and *SPER News*, the Society's in-house newsletter, published four to six times a year. Persons applying for membership between 1 July and 31 December pay \$45.00 or \$37.50 respectively. These fees include GST. Overseas applicants please add \$10 to cover airmail postage.
